1. Previous Meeting Minutes Questions / Concerns if any.

 Motion was passed by Conyers (Bhavin Patel) and RCA (Saad) teams. No questions / Concerns from previous meeting minutes.

2. Ground Issues

- This meeting had to be scheduled urgently to discuss the ground issues.
- Due to certain problems, new grounds are not ready yet.
- YMCA is also not available on 5/7/17 and 5/14/17.
- YMCA may not be available on 5/21/2017 as per Bhavin Patel.
- Fairview is not available for next 2 months due to construction work by School.
- Oakhill Pitch / Carpet will be rebuilt this weekend i.e. 5/13/2017.
- West Newton new Carpet was put on 5/6/2017.
- Ball distribution has been delayed due to some issues faced by the vendor.

3. League Dues

 Every team must pay their league dues of \$2800 by May 20th. Failure to pay the dues by May 20th will result in forfeit of their games.

- Forsyth Falcons paid league dues of pending \$2300.00 via check.
- The Warriors paid \$900.00 towards league dues via check.
- RCA paid \$500.00 towards league dues via check.

4. Scorecards

- We have noticed that some teams are not using the live scoring feature available via our system.
- Every team have a mandatory requirement of using the app for live scoring. Please make use of this functionality.
- Issues within the new app have been fixed by the vendor.
- Few teams have incomplete scorecards. Make sure each and every scorecard is filled in fully.

5. Incomplete Profiles on the website

- Lot of player profiles are incomplete on the website. Mainly these profiles are missing profile picture or picture is not clearly visible.
- All the profiles should have pictures in which the face of the player is clearly visible. Deadline to complete this process is May 20th.

6. Misc Items

- Abid Ali raised question on why 5/21/17 and 6/4/17 schedule was flipped. Viral Bhai explained how Star Division Round-Robin phase is being played and the various requests that we had taken into consideration. We have tried to accommodate every possible request which we had received before preparing the schedule.
- Venu requested why don't we publish meeting dates in advanced or at least give us 1 week notice. Motion was passed by Sachin Pande to schedule meeting on third Thursday of every month and this motion was seconded by Venu Pisike. Going forward our league meeting will be scheduled on every 3rd Thursday of the month from Feb to October.
- Request came in that every team should make use of the live scoring feature starting 5/14/2017 games. Suggestion from Eshwar came in stating First offence is to discuss the issue on why the live scoring was not used and guide them on how to perform live scoring via app. Further recommendations came in and Sachin Pande is going to put in words on the various options which we can go with and amend it in the constitution for the live scoring requirement.
- Abid Ali mentioned we will have 6 teams for the Memorial Weekend tournament and each team will be playing 3 games and top 4 teams will be playing the play offs.
- Due to ground issues, Grass cutting fees will be adjusted once we finalize the amount. Non-availability of the new grounds and existing grounds is impacting the calculation factor currently.
- We will be mailing the teams uniforms to the team's captain directly.
